# CJH9 & LoudBoyz Liability Waiver, Medical Release & Media Consent

For Minors & Adult Participants

This form must be completed by a parent or legal guardian for all participants under 18.

#### 1. Assumption of Risk

I understand and acknowledge that participation in baseball training, practices, conditioning, clinics, lessons, camps, team events, scrimmages, games, tournaments, and any related activities with **CJH9 Baseball Training** and/or **LoudBoyz Baseball Organization** (collectively referred to as "the Organization") involves inherent risks. These risks include, but are not limited to:

- Physical injury (minor or severe)
- Muscle strains, sprains, fractures, and concussions
- Impact with balls, bats, equipment, and other players
- Weather-related exposure
- Accidents during transportation to or from events
- Risks associated with indoor and outdoor facilities

I voluntarily assume all risks, known and unknown, associated with participation.

## 2. Release of Liability

In consideration for my child's participation, I hereby release, waive, and discharge **CJH9**, **LoudBoyz**, all coaches, trainers, staff, volunteers, team representatives, facility owners, independent contractors, and any affiliated partners ("Released Parties") from:

- Any and all claims
- Liability
- Demands
- Actions
- Causes of action
- Damages of any kind

arising out of or related to participation in any Organization activity, whether caused by negligence or otherwise, to the fullest extent permitted by law.

I agree not to bring any claim or lawsuit against the Released Parties for injuries or damages sustained by my child before, during, or after participation.

#### 3. Medical Authorization

I certify that my child is physically able to participate in baseball activities and has no condition that would prevent safe involvement.

I authorize the Organization and its staff to:

- Provide basic first aid
- Seek emergency medical treatment
- Transport or arrange transportation for emergency care
- Contact emergency personnel if needed

I understand that I am responsible for all medical costs arising from any injury or illness.

## 4. Concussion & Injury Acknowledgment

I understand the risks of concussion and other sports-related injuries.

#### I agree to:

- Immediately notify coaches if my child shows signs of injury
- Follow all return-to-play guidelines
- Allow removal from activity if a coach or trainer determines it is necessary

I acknowledge the Organization is not responsible for medical evaluation, diagnosis, or treatment.

#### 5. Behavior, Conduct & Safety Expectations

I understand that athletes and parents must maintain appropriate behavior on and off the field.

I agree that:

- Coaches may remove an athlete from practice or games for unsafe or inappropriate behavior
- Repeated violations may result in suspension or removal from the program
- No refunds are issued for dismissal due to misconduct

I agree to follow all rules and guidelines provided by CJH9 and LoudBoyz.

#### 6. Facility & Equipment Release

I acknowledge that training may occur at third-party facilities independent of the Organization. I release those facilities and their staff from liability in the same manner described above.

I assume full responsibility for:

- My child's use of equipment
- Personal belongings brought to activities
- Loss or damage to personal items

#### 7. Photo, Video, and Media Consent

I grant full permission to **CJH9**, **LoudBoyz**, and affiliated photographers/videographers to capture and use photos, videos, and audio recordings of my child for:

- Training review
- Marketing materials
- Social media
- Websites
- Promotional content
- Highlight reels
- Team showcases
- Recruiting content

#### I understand that:

- No compensation is provided
- Media may appear publicly
- All content becomes the property of the Organization

If I wish to revoke media permission, I must do so **in writing**, acknowledging that previously released content cannot be removed.

# 8. Financial Responsibility & Refund Agreement

I understand and agree that:

• All payments, training fees, team fees, and event fees are non-refundable

- Missed sessions, cancellations, or no-shows are non-refundable
- Refunds may be considered **only** for verified emergencies (family death, hospitalization, or major medical event)
- Non-payment may result in removal from training or team activities

I accept full responsibility for all charges associated with my athlete's participation.

#### 9. Parent/Guardian Certification

- I have fully read and understand this waiver and release
- I voluntarily agree to all terms and conditions
- I understand this waiver is binding to the fullest extent permitted by law
